

Belly Dancing Ranwa Performance Contract

This contract represents the complete terms and conditions between _____ (“client”) and Ranwa El-khoury.

1. Ranwa shall provide:

- d) If appropriate, the performers will encourage audience participation. Guests of honor and other audience members may be invited onto the stage to dance, but the performers will not force those who are uninterested in participating.
- e) The performers shall provide music in the form of a CD by the dancers.

2. The client shall provide:

- (a) A signed contract prior to the event. Clients may also pay in full when sending the contract if that is more convenient.
- (b) A deposit of \$ _____ is required before the performance.
- (c) The payment in the amount of \$ _____ is due immediately following the performance.
- (d) Checks can be made payable to **Ranwa El-khoury**. Cash is also accepted.
- (e) If the performance is canceled less than 5 days prior to the event, payment in full is still required. No fee will apply to venues that cancel more than 5 days prior.
- (f) A safe and adequate space for the performer shall be provided. This includes a floor or stage space that is free of broken glass, spilled liquids, or other hazardous objects. This also includes an environment that is free of harassment of a sexual nature or otherwise. If the performers deem the environment unsafe for the above reasons, they may leave without rendering services. In that case, the client will still be responsible for paying the full amount.
- (g) A sound system with CD playing capabilities shall be provided, preferably in the same room in which the performance is to take place. The sound system is an important part of the show and should be tested prior to the performance. Louder is recommended and preferred.
- (h) The client shall communicate any special suggestions or requests prior to the beginning of the performance. The performance has been carefully choreographed and it is difficult to make changes once the performance has begun.
- (i) Often the performers will have more than one engagement per night, so it is important that the show start at the agreed upon time. If the performers are required to start more than 30 minutes later than scheduled, an extra charge of \$50 will apply. In some cases, lateness may result in a shorter show or constitute a breach of contract on the part of the client.
- (j) It is important to pay the performer(s) in a timely manner once services have been rendered. If the performers are required to wait more than 20 minutes after the show for payment, an extra charge of \$50 will apply. Often for weddings, payment is left with either the wedding planner or the DJ so that the bride and groom will not be disturbed with this detail. Please help us to get out the door on time so that we can remain on schedule with other events.
